Happy spring! Enclosed, please find your spring 2025 service contract; we ask that you complete and return your contract ASAP **indicating the date you would like your boat available for use** (WE WILL ASSIGN THE LAUNCH DATE). Upon receipt of your completed contract, customers in good standing will be scheduled and notified of your expected launch date. All requests are considered on a first-come, first-served basis and subject to availability. There are many variables beyond our control that can affect your launch, please return your contract early, allowing us the time to meet and hopefully exceed your expectations. We do not want to disappoint.

As a quick note, starting in 2025, New York State requires all motorboat operators to complete the NYS Boating Education Safety Classes and obtain certification under Brianna's Law. For more details, you can visit the official website or contact our office—Linda will be happy to provide information to guide you through the process.

**FULL SERVICE:** The full service contract is a value added, simple and convenient option designed to take the guesswork out of your Spring Maintenance Decisions. By choosing this option you will be following recommended preventative maintenance procedures for your boats mechanical systems. Preventative maintenance is your best hedge against costly mechanical failures and "in season down time". Your boat will be bay-tested and secured in your slip as a courtesy. Additionally, the full service option provides for a **10% Discount** on all materials billed in conjunction with your spring re-commission.

**ITEMIZED SERVICE:** The itemized service option provides you the flexibility of choosing the services you feel comfortable performing and the services you would prefer the professionals to handle.

**INBOARD RUNNING GEAR:** Dickson's offers complete "**below water line**" services; Inboard propeller reconditioning, cutlass bearing replacement, strut alignment, stern tube service / re-packing, rudder packing, rudder adjustment, and hull mounted intake strainer servicing.

**BOTTOM PAINTING / RUNNING GEAR COATING:** **Due to strict NYSDEC regulations, owners are not permitted to anti-foul paint their boats bottom!** All bottom painting to be performed by DMW personal. Again this year we are offering an underwater metal zinc coating "barnacle barrier" for inboard style running gear. Your best bet against inconvenient mid season hauls resulting from fouling/performance issues.

**SHRINK-WRAP REMOVAL:** You may remove your own shrink-wrap. However, you are responsible to separate the wooden supports, and nylon strapping from the plastic. Please bundle the wrap and place it under your boat for collection.

As most of you know, Dickson's is a full service mechanical, electrical, electronics, and marine on-board systems service facility. We are factory authorized sales, service, and warranty dealers for Mercury outboards, MerCruiser sterndrive and inboards, Yanmar diesels, Cummins diesels, Crusader Marine and Onan generators. Our staff are certified marine technicians, and we are an ABYC & NMEA compliant shop.

# SPRING CONTRACT SERVICES

## **Shrinkwrap Removal & Disposal:**

Shrinkwrap removal & disposal, step summer canvas

## **Anti-foul Bottom Paint:**

Prep bottom, light scrape and sand. Apply(1 coat) anti-foul bottom paint.

## **Sacrificial Zinc Anode Replacement:**

Remove and replace running gear and hull zincs (as applicable)

## **Inboard Running Gear Coating:**

Clean/scrape & prep running gear metal surfaces. Apply (2) coats zinc coat barnacle barrier.

## **Hull Mounted Intake Strainer & Sea Valves:**

Clean hull mounted raw water intake strainers actuate sea valves.

## **Gasoline Sterndrive & Inboard Engine Tune Up:**

As applicable: Change spark plugs, rotor, distributor cap, and fuel filters. Check/adjust ignition timing and fuel/air mixture. Clean flame arrester, visual check of hoses, belts, ignition wires...Bay test, perform diagnostic check (all EFI systems are subject to a \$95.00 diagnostic report charge, billed in addition to the applicable tune-up rate) tie-in-slip.

## **Diesel Engine Service:**

As applicable: Spring preventive maintenance procedures as per engine manufacture seasonal/hourly maintenance schedules. Service primary and secondary fuel filters / change elements. Inspect air heater, glow plug operation. Inspect belts, hoses, check fluid and bay-test, perform computer diagnostic check (as applicable) tie-in-slip.

## **Outboard Engine Tune Up:**

As applicable: Change spark plugs, and fuel filters. Check/adjust ignition timing and fuel/air mixture. Clean air intake filters, visual check of belts, hoses, ignition wires... lubricate service points. Bay test, perform diagnostic check (all EFI systems are subject to a \$95.00 diagnostic report charge, billed in addition to the applicable tune-up rate) tie-in-slip.

## **Generator Maintenance:**

Service performed as applicable to gas or diesel engines see above descriptions.

## **Inboard Engine Transmission Service:**

Change transmission fluid and filter (as applicable) lube service points.

## **Inboard Engine Alignment:**

Visual check of engine mounts and engine to shaft coupling alignment.

## **On-Board (BOAT) Systems Recommission and Check:**

As applicable: Recommission systems\*\*(ie: domestic water, head, saltwater washdown/baitwell, air conditioning, etc ...). Check operation and repair minor deficiencies of navigation lights, horn, bilge pumps and 12v accessories.

**\*\*Note: All systems will be recommissioned unless advised otherwise on contract.\*\***

## **Battery Re-installation:**

Clean connections and re-install batteries.

## **Components Re-installation:**

Outrigger, electronics, life raft... re-installation.

## **Hull Only Detail:**

Wash, compound and wax hull from waterline to rub rail

## **Full Exterior Detail (Hull, Topsides & Cockpit):**

Compound, wash and wax hull and topsides. Polish stainless steel, clean windows, exterior carpets, cockpit compartments, and helm area. Clean cockpit deck/ fish boxes, prep/dress cockpit sole (cabin not included)

## **Cabin Cleaning Service:**

Vacuum carpet, upholstery, and head liner. Wipe down counter surfaces, clean windows, mirrors, head, galley areas, and appliances (Note: Carpet shampooing, and/or heavy mold removal not included)

## **Exterior Teak Maintenance:**

Strip oil and brighten teak, apply two coats of oil/sealer.
